RULES AND REGULATION

1. The Name of the Society :- **Yuva Jagriti Association**
2. The office of the Society is
Situated in the provinces/State :- TN Road, Vill-Pakaipar, P.O- Kabuganj, Dist:-
Cachar, Assam, Pin- 788121
3. Area of operation :- The area of operation of the society shall be whole
North East, INDIA.
4. **The objects for which the society is established are:
(The objects must be scientific, charitable, literary etc.)**
 - a) To promote rural development without creating sharp inequalities priorities shall be given to creating substance base for the weaker sections by using land and water resources judiciously, with emphasis on reduction of external inputs and thereby creating a model which is replicable.
 - b) To seek and promote participation of women as well as youth in the development process so as to encourage co-operative and group action.
 - c) To improve the status of health & Hygiene enjoyed by the community by full involvement of the members of the community.
 - d) To promote technological up gradation of existing know how and explore possibilities of developing appropriate technology.
 - e) To explore avenues where the input from science and Technology can reduce drudgery of human beings, especially women, while increasing the productivity.
 - f) To identity and promote vocations suitable to the local situation and impart necessary training to the youth.
 - g) To improve the functional literacy of people.
 - h) To create awareness for protection of environment and to ensure that development strategy followed by the Govt. is congenial to maintaining ecological balance.
 - i) To promote educational facility to the poor children those are not able to do it.
 - j) To promote economic development to the community by providing and resourcing the financial facility from various sources.

5. Membership:

- a) **Qualification to become Members:** - The membership of the association thrown open to all Indian citizens those are residing presently within the area of operation of the society bearing good moral character.
 - b) **Subscription, Donations etc.:** - The admission fees will be Rs 500/- for professional and Rs. 250/- for students. For institutions membership fee will be Rs. 5000/- and for Corporate membership fee will be Rs. 7000/-
 - c) **Collection of Fund:** - Admission fees, monthly subscription, donations etc. will be resources of the fund of the society.
 - d) **Control of Fund:** - Fund will be collected from different resources shall be deposited in a any Bank in the name of the organization and any two members of the Executive Committee (mainly Gen. Secy. And President) will jointly operate the Bank Account.
6. **Procedure of the General Meeting:** The General Meeting of the society will be held twice in a year. The General Secretary in consultation with the President will fix the date and time and agenda and convey the meeting with a prior notice to all the members before seven days.
7. **Quorum of the General Meeting:** 1/3rd of the total members of the society shall from the quorum of the General Meeting.
8. **Election Procedure of the Executive Committee:** - The Executive Committee will be elected by the General Meeting from amongst the members of the NGO.
9. **The term of the Executive Body:** - The term of the Executive body shall be 3 years. The term may be extended or reduced by the decision of a General Meeting.
10. **Procedure of Re Election of the members of the Executive Body:** - The members of the Executive body are entitled to be re-elected in Annual General meeting. The defaulter members will not be entitled to be member of the Executive Committee.
11. **Procedure of the meeting of the Executive Body:** - There shall be at least one meeting in every quarter and four such meetings shall be held in a year. The Governing Body may meet more frequently if required.
12. **Quorum of the meeting of the Executive Body:** - Quorum of every Governing Body meeting shall be 2/3rd of the total strength of the Governing Body. In the case of absence of the quorum, the meeting shall stand adjourn but shall meet after half an hour at the same place to transact the business of Agenda without quorum thereof.

13. **Expulsion of undesirable member:** - Any member of the society who goes against the rules and regulations of the Society will be disqualified and may be expelled from the society. Any member defaulter in respect of payment of monthly or yearly subscriptions then his right to vote will be ceased.

If any Executive member fails to attend in three consecutive meeting without any information then he/she may be barred from the Executive body

14. **Auditor:** -A qualified auditor will be appointed by the Executive Committee who shall audit the account of the Society at least once in a year and Annual Audit Report will be submitted to the Registrar of Societies regularly.

The financial year will be assessed from 1st April to 31st march.

15. **Legal Procedures:** - according to the provision laid down in the section 6 of the Societies Registration Act. XXI of 1860 the society may sue or may be sued in the name of the General Secretary or President of the Society.

16. **Dissolution:** - if necessary the society may be dissolved and the properties remained after dissolution may be handed over according to the provision laid down in the section 13 and 14 of the Societies Registration Act XXI of 1860.
